

**UNITED WAY ROOM MAKEOVER SWEEPSTAKES
OFFICIAL RULES**

1. **NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN. PURCHASE OR DONATION WILL NOT INCREASE CHANCES OF WINNING.** United Way Sweepstakes (the “Sweepstakes”) begins on August 15, 2016 and ends on January 31, 2017 (“Promotional Period”). **Odds of winning depends on the number of eligible entries timely received.**
2. **ELIGIBILITY.** Open and offered only to persons who are legal residents of the United States, 18 years of age and older when Sweepstakes begins. Employees and directors of the Watertown Area United Way and Montgomery’s (collectively, the “Sponsors”), and their parent entities, subsidiaries and affiliated companies (and their respective IRS dependents, immediate family members and individuals residing in their same household) are not eligible to participate. Void in New York, Florida, Rhode Island, Puerto Rico and where prohibited. By participating, entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor whose decisions are final and binding in all respects and waive any right to claim ambiguity in the Sweepstakes or these Official Rules.
3. **HOW TO ENTER:** Enter one of two ways: (1) complete an official United Way entry form, your pledge card from the United Way will serve as your official entry form, when you make a first time donation to the Watertown Area United Way organization of \$52.00 or more, or increase your previous year’s donation by \$52.00 or more during the Promotional Period; or (2) hand print your complete name, address, city, state, zip code, date of birth, daytime telephone number, and e-mail address (optional) on a 3”x5” card. Entry forms received from an employer should be returned to that employer, all other entries should be mailed in a first class stamped envelope to: Watertown Area United Way, 818 S. Broadway, Suite 104, P.O. Box 283, Watertown, SD 57201. Entries must be postmarked or received by January 31, 2016.

Limit one (1) entry per person. Participants who attempt to enter multiple times will be disqualified. The Sponsors, their respective parent companies, affiliates, subsidiaries, distributors, participating retailers and advertising and promotion agencies, and all of their respective officers, directors, shareholders, employees, agents and representatives (collectively, “Released Parties”) are not responsible for illegible, lost, late, damaged, incomplete, misdirected, undeliverable, mutilated, destroyed, stolen, or postage due mail-in or official entries, or for the incorrect or inaccurate entry information whether caused by equipment, programming used in this Sweepstakes, printing, human processing or other error, or otherwise. All entries submitted become property of the Sponsors, and will not be returned.

Entries are null and void and will be rejected if not submitted in accordance with these rules and through authorized, legitimate channels, or if they are from other games or sweepstakes, if they are copied, computer generated, or mechanically reproduced, or if any part of an entry is counterfeited, illegible, mutilated or tampered with in any way, or if they contain or reflect printing, typographical, mechanical, or other errors.

4. **DRAWING:** A random drawing will be conducted on or about February 15, 2017 from among all eligible entries timely received by the Sponsors, whose decisions are final and binding in all matters relating to this Sweepstakes. The winner will be notified by telephone, mail and/or e-mail depending on the information provided upon entry on or about February 22, 2017.
5. **PRIZES/ODDS:** 1 Grand Prize: One (1) Room Makeover. Approximate Retail Value (“ARV”) \$5,000. Total ARV \$5,000. **Odds of winning depends on the number of eligible entries timely received.**

Only the stated prize will be awarded. In the event that production, printing or any other reasons cause more than the stated number of prizes set forth in these Official Rules to be claimed, the Sponsors reserve right to award only the stated prize.

Winner is solely responsible for all applicable taxes, (including, but not limited to, federal income taxes), insurance, licensing, registration, title fees and costs, and other expenses that may be required for the enjoyment and use of the Room Makeover. Winner may be required to show proof of valid driver's license and insurance prior to taking delivery and pick up of the Room Makeover as directed by the Sponsors. Winner is responsible for picking up the Room Makeover within 30 days of being notified that he/she is the winner and that the Room Makeover is ready for pick up (the "Notification"). In addition, the winner will be required to sign and return an Affidavit of Eligibility, Release of Liability and where lawful a Publicity Release within seven (7) days of Notification. In the event of non-compliance with these requirements the Room Makeover may be forfeited and an alternate winner selected by random drawing among all remaining eligible entries timely received by Sponsors.

Any other prize details will be at the sole discretion of the Sponsors. Expenses not stated in these Official Rules are solely the responsibility of the winner. Winner may not substitute, assign or transfer prizes, or redeem prizes for cash, but the Sponsors reserve the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable. Prizes will not be fulfilled outside the United States or where this Sweepstakes is void. Should a prize be won by a minor in his/her jurisdiction of primary residence, such prize must be accepted on the minor's behalf by the minor's parent or legal guardian. In addition, all affidavits, releases and undertakings, to be signed by the winner as set forth in these Official Rules must be executed and undertaken by the parent/legal guardian of the minor, both on such parent/legal guardian's behalf and on behalf of the minor, or prize will be forfeited and awarded to an alternate winner.

6. **CONDITIONS OF PARTICIPATION: Participants agree (a) to abide by these Official Rules and all decisions of the Sponsors, which shall be final and binding in all respects relating to these Sweepstakes; (b) that Released Parties will have no liability whatsoever for, and shall be held harmless by the winner against any liability for any injuries, losses or damages of any kind to persons, including death, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in this Sweepstakes or any Sweepstakes related activity; or for any typographical or other error in the printing, offering or announcement of any prize via entry forms, posters or any other media; (c) except where legally prohibited, to grant (and agree to confirm that grant in writing) permission for the Sponsors and those acting under their authority to use his/her name, photograph, voice and/or likeness, for advertising, trade and/or publicity purposes without additional compensation in all media now known or hereafter discovered, worldwide, without notice, review or approval; (d) that the Sponsors may collect the personal information submitted by participant, and use the information pursuant to the Sponsors' privacy policy's available: (1) 605-886-5815; (e) that winner (and winner's parent/legal guardian, where applicable) may be required to complete, sign, and return an Affidavit of Eligibility, a Liability Release and, where lawful, a Publicity Release within 7 days from the date of receipt of such documents, and that if documents are not returned on a timely basis, or if any prize notification or prize is returned as non-deliverable on account of inaccurate or incomplete entry information or otherwise, or if winner is found to be ineligible or not in compliance with these Official Rules, such prize will be forfeited and awarded to an alternate winner; (f) if no alternate winner can be selected for a given prize, for any reason, by March 22, 2017 the prize will be forfeited in its entirety and will not be awarded to any Sweepstakes Participant; and (g) the Sponsors may disqualify anyone from participating in the Sweepstakes or winning a prize if, in their sole discretion, they determine that such person is attempting to undermine, tamper with, or abuse any aspect of the Sweepstakes, by cheating, deception or other unfair playing practices, or intending to annoy,**

abuse, threaten or harass any other entrant or the Sponsors' representatives and the Sponsors reserve the right to terminate such Participant's eligibility. ANY ATTEMPT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSORS RESERVE THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT OF THE LAW, INCLUDING CRIMINAL PROSECUTION.
